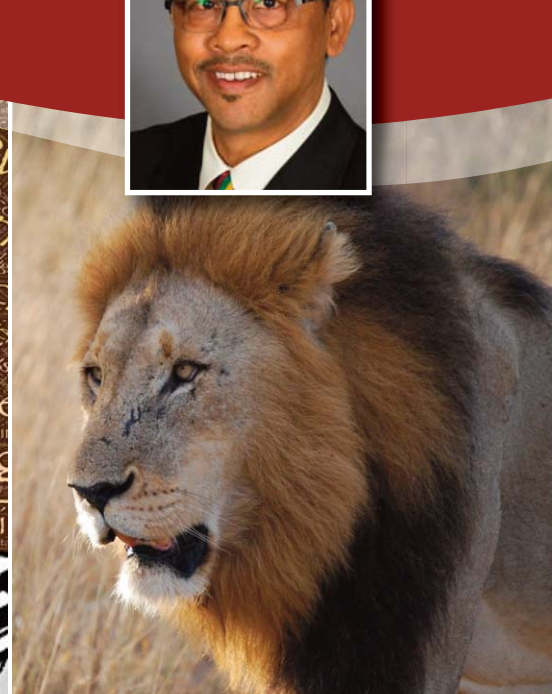
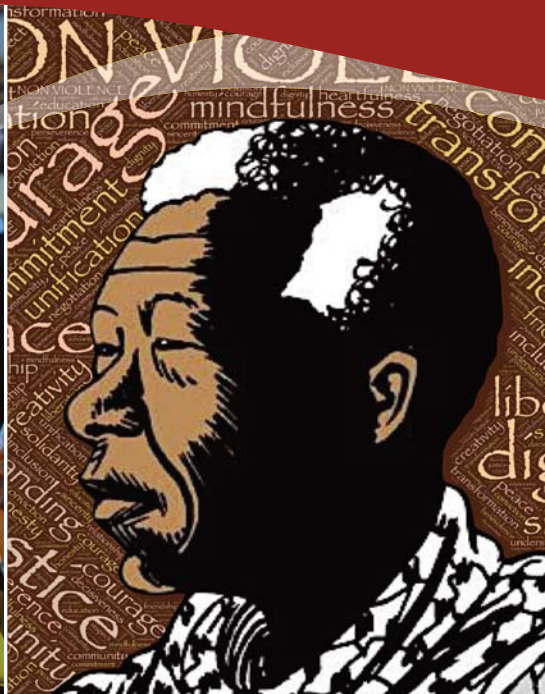

# The Legacy of Mandela South Africa

## October 5 & 6, 2017 – Depart USA & Arrive in South Africa

Your journey begins when you depart on your international overnight flight to South Africa. Transfer to your Johannesburg hotel for dinner and overnight.

## October 7, 2017 – Soweto Township

After breakfast, begin your one of a kind **Soweto** Day tour. You will smell the pavement cooked meals, become part of the buzz on the streets and meet the people as they go about their daily chores. Enjoy lunch with a local family in the township. This afternoon, visit the **Hector Pieterse Museum** in memory of the young schoolboy who was shot in the 1976 Soweto Uprising. Next, spend time in the **Mandela Family Museum** where Mandela lived from 1946 to 1961 and where his family continued to live while he was in prison. Lastly, enjoy dinner at **Wandies Place**, a cozy restaurant in the middle of Soweto. Wandies is popular with both locals and tourists alike, hosting international stars such as Evander Holyfield, Jesse Jackson and Quincy Jones.

## October 8, 2017– Johannesburg, South Africa

Today you will visit the **Apartheid Museum**. Opened in 2001, the museum is the world's pre-eminent museum dealing with 20th century South Africa. The exhibits will take you through a dramatic emotional journey that tells a story of a state-sanctioned system based on racial discrimination and the struggle of the majority to overthrow this tyranny.

## October 9, 2017 – Kruger National Park Game Drive and Safari

After breakfast, board a flight to **Kruger National Park**. Join your expert guide for an afternoon game drive with the intent of spotting the big five: Lion, Elephant, Leopard, Buffalo and Rhino. Your sight-seeing vehicle will take you on and off road through the bush of Africa's most diverse environment. Tonight, enjoy a traditional Boma dinner under the canopy of African starlight.

## October 10, 2017 – Kruger National Park

Arise early for your second chance to see the African wildlife on your morning game drive. The balance of your day is free to enjoy your resort accommodations, visit the **Moholoholo Rehabilitation Center** or rest. Dinner will be on your own tonight.

## October 11, 2017 - Cape Town, South Africa

This morning, we depart Kruger and fly to **Cape Town** via Johannesburg. On arrival, enjoy a panoramic bus tour including City Hall, St. George's Cathedral and Signal Hill before checking into your centrally located hotel which will remain your home for the remainder of your stay.

## October 12, 2017 – School Visit, Castle of Good Hope & Table Mountain

This morning, visit a **local school** and spend time with the children (donations may be delivered if arranged ahead of time). After lunch, visit the **Castle of Good Hope**, the oldest surviving building in South Africa. This pentagonal fortification built in the mid 1600's was a maritime replenishment station for the Dutch East India Company at the Cape of Good Hope. Next, visit the famous **Table Mountain**. With a 360 degree view of the Cape Peninsula's mountains, oceans and the suburbs below, there is no better view in South Africa. **This evening, a Warden from Robben Island will visit and speak to the group about the time he spent with Mandela.**

## October 13, 2017 – Robben Island & Slave Lodge

This morning, we will take a boat ride to the notorious **Robben Island**. The prison, located on an island seven kilometers off the coast of Cape Town, is where Africa's political prisoners were kept during the colonial and Apartheid years of South Africa. During your guided tour of the grounds where Nelson Mandela was held for imprisoned for 18 years, you will hear the stories that took place inside the prison walls and get a better understanding of the great men that overcame so much. After returning from Robben Island, enjoy time to dine and shop at the beautiful **V&A Waterfront** in the heart of Cape Town. This afternoon, visit the **Slave Lodge**. Once a government office building and home of the Supreme Court, the newly renamed Slave Lodge hosts a variety of exhibitions raising awareness around the history of human rights issues. This evening we will go to **GOLD**, a vibrant, eclectic Pan-African restaurant offering a taste of foods from across Africa, an interactive drum circle where you will learn how to play the djembe, and enjoy traditional dramatic tribal dance performances.

## October 14, 2017 –Return to USA

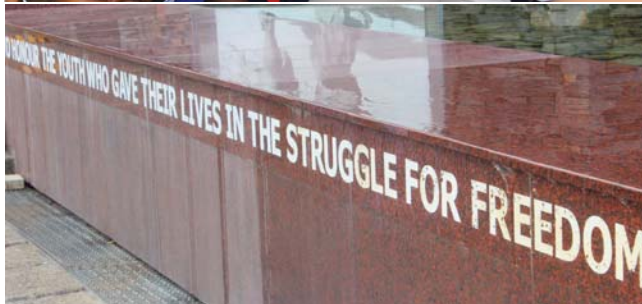

**AIRLINE ROUTES and TICKETS:**
